ADMIN ASST SARANTO stated that as of June 10, 2019 our bank will no longer be Idaho Independent Bank. First Interstate Bank has bought them out. The downside to this is First Interstate Bank only allows a very limited amount of transactions a month in your checking and does not have visa cards, they have MasterCard's. Each Mastercard will have a \$50 annual fee for a maximum of \$200. Since we have four visa cards, we would meet the \$200 maximum.

I looked into Mountain West Bank and their business checking is free as long as you keep \$1,000 in it and you have up to 3,000 transactions a month; we should never need that many. They also have visa cards with no annual fee.
