BEN JOHNSON from Ben point Road, I've been there for 18 years. We had our road association meeting this past week. We had 45 out of 72 residents at the meeting. The issue that I had raised was there is a subdivision pending on one of the lots on our road. This parcel is landlocked and does not have beach access. At what point will the fire district require the road to be brought up to current standards and not consider it grandfathered in at 12 feet wide? Our concern is there are other parcels that could be subdivided which would increase the activity on the road.

DEPUTY CHIEF MAINES: Chief Sneve submitted this to our attorney Chuck Lempesis for his interpretation of "grandfathered in".

BEN JOHNSON is concerned about the precedent that might be set. The California investors that are subdividing these parcels won't be around in the future when the road needs to be widened to share in the cost.

It was briefly discussed further and was decided to wait until we received our attorney's interpretation of "grandfathered in".
